exercise more control over humanity. It is estimated that the Global Elite numbers about 8,500 members, while there are 8 billion of us.<sup>327</sup> That equates to approximately, one in a million are members of the Global Elite who orchestrate regime changes behind the scenes of every day politics.




"pandemic" creates the perfect ambiance to do so. If our political leaders were actually honestly concerned about public health, then a lockdown might have been an option if carefully orchestrated.

The International Emergency was first declared when the World Health Organization (WHO) officially announced COVID-19 was a "pandemic" on March 11, 2020.<sup>333</sup> This was several months after the initial outbreak in Wuhan, China in November 2019.

WHO was on the fence about declaring it a pandemic for months. WHO collaborated with China on concealing the extent and seriousness of this pandemic.<sup>334</sup>

Years ago, China bought its influence and economic power into the United Nations (UN), thus China was a large part of influencing the UN's decisions and actions regarding COVID-19.

Even though the U.S. was the largest single funding source for WHO<sup>335</sup>, the Gates Foundation funded GAVI<sup>336</sup> and China had more medical and international



influence and power than its U.S. counterpart.

On April 14, 2020, U.S. President Trump suspended funded WHO and wrote a scathing letter detailing his reasons for doing so.<sup>337</sup>

By the time WHO declared COVID-19 a pandemic, it had already spread around the world including the U.S. with the first positive test case in Seattle, Washington on January 21, 2020.<sup>338</sup>

A U.S. intelligence officer claimed that early alarms about the pandemic went unheeded.<sup>339</sup>



After the National Emergency was finally declared by U.S. President Donald Trump on January 31, 2020,<sup>340</sup> other countries followed suit.

It is important to understand that a "Declaration of National Emergency" opens up federal funding for states and public health agencies while certain

emergency powers then become available.<sup>341</sup>

"Martial Law" is declared in the case of insurrection, rebellion or civil war. If martial law is declared, then the U.S. military can be brought in by the U.S. President to enforce law and order. Martial law, if declared, suspends the U.S. constitution as was done during the Civil War and as well as once during WWII.

Martial law is an extreme and rare measure used to control society during war or periods of civil unrest or chaos. Martial law on the national level may be declared by Congress or the president.

If Martial law<sup>342</sup> is declared, the "continuity of government" emergency operation takes hold and the U.S. President is ushered off to a secure bunker and constitutional government is temporarily suspended.<sup>343</sup> As of August, 2020, U.S. President Trump has not declared "martial law", and to his credit, he refrained from declaring such in response to looting and rioting during the protests.

### **U.S National & State Emergencies**



These emergency powers can be extended lawfully by the consent of the state legislatures. This "Declaration" also activates the National Guard as needed by the states.<sup>344</sup>

What was deeply disturbing about the U.S. States, notably those U.S. States with Democratic Governors, was the extent to which these Governors expanded their emergency powers beyond what a sound pandemic response might be.

Unfortunately, the Democratic Governors went to great lengths during an election year to make the pandemic response a partisan, political circus to make Republican Governors and U.S. President Trump appear incompetent in the eyes of the public.

other researchers opined that shutdowns were pointless for containing COVID-19.349

Former U.S. Congressman Ron Paul went so far as to suggest that the coronavirus was a hoax.<sup>350</sup> Trump had indicated a similar sentiment in the beginning. South Dakota is considering the first state bill to outlaw all vaccine and medical mandates.<sup>358</sup> Meanwhile in April 2020, Adams County, Colorado voted against mandatory vaccines.<sup>359</sup>

fact, suggestions or recommendations, not law. The COVID-19 pandemic is exposing tyrants all over the U.S.<sup>366</sup>

Indiana Governor Eric Holcomb signed an Executive Order which will mean a statewide mask requirement which came into effect in Indiana. Those who don't follow the new order could be charged with a Class B misdemeanor, which is punishable by a fine and up to six months in jail.

Governor Holcomb decreed that all residents and visitors in the state will be required to wear face coverings such as masks in public or risk facing a criminal charge. Since when does a Governor

# U.S. State Governors Exceeding 30-Day Time Limits on Emergency Authority

Supreme Courts have ruled that even during a state emergency, governors have a 30-day window to respond to such emergencies. Beyond that 30-day window, which can be renewed, governors require the consent of their state legislature to enforce their decrees.

Attorney Mari Foreman Groff says these state governors are pushing beyond the limits of their emergency powers.<sup>370</sup>

The Michigan Supreme Court backed a barbershop that stayed open in rebuke of dictatorial governor's restrictions.<sup>371</sup>

Meanwhile, the Wisconsin Supreme Court struck down Governor Tony Evers "safer at home" order since he didn't have the consent of the state legislature to uphold the order.<sup>372</sup>

"At the end of June 2020, the governors of New York, New Jersey and Connecticut announced that anyone coming into their states from other states identified as coronavirus "hot spots", now up to 19 states, are required to quarantine themselves for 14 days upon entering.

Ironically, Gov. Andrew Cuomo of New York earlier in the "pandemic" called a similar policy put in place by Rhode Island unlawful for those from New York, then threatened to sue Rhode Island.

State-to-State travel restrictions are constitutionally dubious and deeply problematic, because they violate the separation of powers between the state and federal governments. U.S. State Governors have no authority whatsoever to limit interstate commerce or travel.

Although governors have been granted emergency powers to respond to a pandemic, these powers have limits. In particular, governors can only exercise the power that has been granted to them by the legislative branches of their state. Constitutional guarantees, such as the right to due process and the right to travel, further constrain the governors' emergency powers.

Most state legislatures have recognized that the power to quarantine



or isolate infected individuals is a critical tool in a governor's pandemic response arsenal. However, ordering someone not to leave their home is a significant incursion on liberty. Accordingly, state legislatures have placed stringent limitations on the exercise of this power."<sup>373</sup>

### **U.S. State Emergency Decrees**

Washington State residents who refuse a COVID-19 test are to be placed under house arrest.<sup>374</sup> This is a shocking violation of our civil liberties and rights as U.S. citizens.

Meanwhile, Ventura, California police can now enter and remove you

The Los Angeles Mayor has threatened to cut power and water for

businesses violating the "safer-at-home" COVID-19 order or hosting large parties or gatherings.<sup>376</sup> A Los Angeles sheriff shut down all gun stores, then released 1,700 inmates.<sup>377</sup>

San Diego, California citizens face \$1,000 fines or jail time for "watching the sunset" at beaches.<sup>378</sup> California police were in the process of arresting a woman for going to the beach. When dozens of other people joined her, the police let her go and stood down.<sup>379</sup> California police in some cities used drones to patrol the lockdown.<sup>380</sup>



The Colorado Governor ordered health food stores to close, but other grocery chains are considered essential services and allowed to stay open.<sup>393</sup> Nevada Governor ordered closures of health food stores, for example Whole Foods.<sup>394</sup>

The Governor of Vermont decreed home farming "non-essential" and closed down seed stores as did the unpopular Governor of Michigan.<sup>395</sup> In the midst of a food shortage why would any authority stop us from buying seeds or gardening supplies?<sup>396</sup> These scenarios are a dress rehearsal for a total police state.<sup>397</sup>

#### **U.S. Police State**

Do U.S. State Governors have the right to decide which human activities and businesses are essential and which are not?<sup>398</sup> Does New Jersey Governor's restrictions violate Bill of Rights?<sup>399</sup>

The U.S. Department of Justice (DOJ) declared that it would support legal action if the U.S. State Governors restrictions go too far and violate the U.S. Constitution or Bill of Rights.<sup>400</sup> For example, the Justice Department backed businesses challenging Michigan's pandemic restrictions.<sup>401</sup> Attorney General Barr spoke out on lockdowns,

warning that, "We are killing the patient."402

According to legal researchers and constitutional attorneys, various state governor shutdown orders are unconstitutional and beyond their authority to execute.<sup>403</sup>



### 20. COVID-19 & The 5G Factor

Is it just a "coincidence" or is there a connection between the large-scale deployment of 5G technology and COVID-19? For a brief summary of 5G radiation, read Create Healthy Homes: "5G Brief Summary" and "5G Synopsis".412

There are plenty of theories due to international studies regarding the detrimental health effects of 5G millimeter wave radiation distinct from the 4G microwave radiation. In a Russian study, thousands of birds fell from the sky. Dana Ashlie does an interesting analysis, though of the connection between COVID-19 and 5G radiation which inspired us to think about any correlation.<sup>413</sup>

From one perspective, the COVID-19 virus, if it is a virus, may spread whether we have 5G or not. Human beings catch viruses, some people get sick, and unfortunately, some people die whether from the seasonal flu or COVID-19. Usually, a virus then disappears for a season, mutates and returns for another round.

5G has an impact on the healthy immune system of human beings. It is well-established that radiation does suppress immune functions. If one is exposed to 5G (or 4G) radiation for extended periods of time, for example, when living, sleeping or working near an antenna, router or modem with a high-use of mobile phones, or home lines with radio-frequency extensions, symptoms such as headaches and fatigue may arise. Thus, one may become more susceptible to a viral infection or COVID-19.

Was it also a coincidence that COVID-19 had its debut in Wuhan, China immediately after 5G was fully deployed

in that city with thousands of antennas, or that New York City had just activated an extensive 5G system immediately prior to the "outbreak" of COVID-19?<sup>414</sup>

What is the extent of a correlation between the seriousness of the COVID-19 outbreak, the mysterious strokes, people falling dead in the streets of Wuhan (or were these videos faked), the heart failures, and the death rates in areas where 5G had been recently deployed such as New York City, Los Angeles, Atlanta?<sup>415</sup> Why are otherwise brilliant scientists, the U.S. government, FDA, FCC, and the mainstream media ignoring these correlations?

Robert F. Kennedy, Jr. of Children's Health Defense, did not find sound scientific evidence to support the theory that 5G is the cause of the COVID-19 epidemic, 416 though he believed that 5G may be a contributing factor.



form of non- ionizing radiation. Parts of the body nearest to the antenna can absorb this energy. We have been led to believe that the cell phone away from our heads will minimize the radiation.

However, after using an EMF (electro-magnetic frequency) detector, it was revealed that cell phone radiation, routers, modems and home lines were still in the red zone up to 10 feet away.

In recent years, the number of cell phone calls per day, the length of each call, and the amount of time people use cell phones have increased. Steer clear of high-powered antennas, 4G and especially 5G towers.

#### How to Remediate the Effects of 5G

First and foremost, greatly reduce or eliminate your use of mobile phones

whenever possible. To remediate the effects of the mobile phone, do not use your mobile phone or home phone near your head. Use the speaker phone instead of the handset, which actually only helps minimally. Keep your mobile phone away from your sleeping space. Shut down your Wi-Fi router or modem at night while you sleep or when not using it.

Then, adapt your laptop, desktop computer or cell phone to connect directly via an ethernet cable to your router or modem.

Create a safe room or safe house with a Faraday cage<sup>420</sup> if possible. A Faraday cage will shield mobile phone signals, 5G, Wi- Fi, DECT, smart meters, EMF RFID and other electromagnetic radio frequency radiation.



In the alternative to a Faraday cage, purchase a few Faraday pouches to shield mobile phones and larger Faraday bags to shield routers, modems and home phones when Wi-Fi is neither needed nor being used. These convenient Faraday pouches or bags are essential for minimizing EMFs and are inexpensive.

If you purchase an EMF meter you can measure the amount of radiation being emitted, thus design your office and home space accordingly to minimize harmful radiation. One can also ground EMF radiation in your home or office by sitting or sleeping on "earthing" sheets plugged into the ground socket of any convenient receptacle for a better night's sleep.

The National Toxicology Program was commissioned by the FDA.<sup>421</sup> How safe is electromagnetic radiation due to cellular, wi-fi and Bluetooth technologies?<sup>422</sup> Read the study on the "Effect of Electricity, Electromagnetics & Antennas on Human Health".<sup>423</sup>

In 1977, 5G technology was tested in Russia on both humans and animals in with disturbing results that showed 5G to be seriously injurious, and sometimes lethal, to human or animal health.<sup>424</sup> In 2020, AirGig technology deployed by



AT&T will transfer 5G directly over the power lines turning them into huge transmitters.<sup>425</sup>

On March, 23, 2020, the <u>"Secure</u> <u>5G and Beyond Act 2020"</u> was signed by U.S. President Trump to provide security for the U.S. telecommunications network.<sup>426</sup>

# 21. Total Surveillance State & The Right to Privacy

Have we grown to become so conditioned to the presence of control at every level of government, and the corporate sector, that totalitarianism doesn't shock us anymore?<sup>430</sup>

Is it not shocking, not even surprising, that the CIA partnered with Amazon for cloud surveillance and RFID locators in 2013 for tracking and microchipping both humans and animals?<sup>431</sup> Or that Bill Gates backed a \$1 billion plan to cover the earth with surveillance satellites<sup>432</sup> and he called for a national vaccine-tracking system?<sup>433</sup>

### **Vaccine Tracking**

U.S. President Trump opposes the Gates-funded vaccine-tracking and contact-tracing system on both constitutional<sup>434</sup> and personal liberty grounds.<sup>435</sup> White House documents

reveal efforts to surveil Americans using contact-tracing.<sup>436</sup> U.S. Attorney General Barr opposes Gates proposed COVID-19 vaccine certificates.<sup>437</sup>

### **Immunity & Health Passports**

A proposed "Immunity Passport" united 60 corporations who claim their "Self-Sovereign ID" project will not compromise the privacy of their users. These companies are working on a digital certificate to let individuals prove (and request proof from others) they have either recovered from COVID-19, have tested positive for antibodies or have received a vaccination.<sup>438</sup> The real danger of a COVID-19 vaccine is the rapid development of "Agenda ID2020".<sup>439</sup>

What is the infamous ID2020? It is an alliance of public-private partners, including UN agencies and civil society. It is an electronic ID program that uses generalized vaccination as a platform for digital identity.

"Health Passports" are being considered in U.K. and other countries. 440 French Polynesia now requires a medical certificate for entry into their country. 441 Mass tracking COVI-PASS "Immunity

Passports" are slated to roll out in 15 countries.<sup>442</sup>

The problem with "Immunity Certificates" like these is that large-scale antibody testing may be a way out of mass lockdowns, however, they are actually human control systems, otherwise pointless and meaningless.

These certificates create perverse incentives for people to expose themselves to COVID-19 so as to be able to resume work or travel internationally. The true aim of these certificates has nothing to do with public health, but to be able to manipulate and control the populace.<sup>443</sup>

Insisting on your rights without acknowledging your responsibilities isn't freedom, it's adolescence.



Beginning in September 2020, Hawaii State Governor Ige, who has been seen meeting with Chinese officials, has required all who enter Hawaii to provide an official negative COVID-19 test for entry upon arrival. Furthermore, temperature checks are becoming more routine in doctors offices and airports. Is it a coincidence the manufacturers designed these medical tools to look exactly like a "gun being pointed at your head"? You decide.

This is the beginning of the slippery slope of the total control and the rise of authoritarianism.

#### **Rise of Authoritarianism**

NSA Whistleblower and privacy advocate Edward Snowden observes the

rise of authoritarianism long before the COVID-19 pandemic.<sup>444</sup> He also explains that COVID-19 gives governments invasive new data-collection powers that could last long after the pandemic.<sup>445</sup>

New tracking technologies that violate our privacy are being implemented during this pandemic.<sup>446</sup> For example, the U.S. has begun to utilize smartphone location data to fight COVID-19.<sup>447</sup> Both the U.S. and the European Union (EU) are implementing programs to track our smartphone location data.<sup>448</sup> The CDC is setting up a COVID-19 a "surveillance and data collection system".<sup>449</sup>

The question is, how many deaths are needed to justify giving governments absolute control of nearly every aspect of our lives?<sup>450</sup> The manipulated fear of COVID-19 could adversely affect privacy and civil liberties forever.<sup>451</sup> Meanwhile in 2019, Facebook was fined \$5 billion by the Federal Trade Commission (FTC) for privacy violations.<sup>452</sup>

Is COVID-19 a psychological scare operation designed to socially engineer a new compliant and obedient society that

### **Contact-Tracing**

Former National Security
Administration (NSA) contractor Edward
Snowden warned that COVID-19
surveillance and contact-tracing could
lead to an abuse of power.<sup>454</sup>

Snowden contends that even though China, Taiwan and South Korea have been using contact-tracing technology to reduce the spread of the virus, governments are also using the COVID-19 pandemic to build an "architecture of oppression".455

The U.S. government is beginning to implement the World Health Organization's "contact-tracing" to forcibly remove people from their homes. 456 California is building an army of disease detectives. California is test state for WHO's contact-tracing. 457 All U.S. states have received substantial funding through the CARES Act to roll out comprehensive contact-tracing protocols door-to-door across the nation.



U.S. President Trump is pushing back against an aggressive contact-tracing

program by withholding funding authorized by the U.S. Congress.<sup>462</sup>

### **Microchipping Humans**

First, it was cattle and livestock, second it was dogs, cats and pets, alas, now it has arrived for humans. The FDA has approved a computer chip to be implanted in humans. While a Wisconsin company has already started microchipped their employees, 464 Trump has meanwhile laid the groundwork to ban mandatory vaccinations. 465

The Centers for Disease Control (CDC) alleged that aggressive contact-tracing is needed to reopen the U.S. economy.<sup>466</sup> In contrast, Norway ended their virus-tracking application, then deleted the data over privacy concerns,<sup>467</sup> while New Zealand prepares to end its lockdown. recognition technology.<sup>469</sup> Washington State has approved a facial recognition law that is seen as a national model.<sup>470</sup>

Thanks to COVID-19, facial recognition technology works better with social and physical distancing in place for tracking purposes, because people are more spread out, thus easier to capture digitally. Hong Kong protesters have been using lasers to block this technology.<sup>471</sup>

### **Global Police State Technologies**

What is happening in the U.S. is happening simultaneously in many countries around the world. U.N. Chief Secretary-General António Guterres, warned that authoritarians are weaponizing the COVID-19 pandemic to subvert human rights.

"Against the background of rising ethnonationalism, populism, authoritarianism and the pushback against human rights in some countries, the crisis can provide a pretext to adopt repressive measures for purposes unrelated to the pandemic." 472

The U.K. has passed the "Coronavirus Bill" with sweeping new powers for government in what may be the most fascist Western regime today.<sup>473</sup>



A former U.K. Supreme Court justice concurs that the coronavirus rules are providing a "hysterical slide into a police state".<sup>474</sup>

Denmark has rushed through an emergency coronavirus bill which gives health authorities powers to force testing, treatment and quarantine with the backing of the police.<sup>475</sup> Swedish citizens are getting chip implants to replace cash

as currencies and coins are rapidly becoming obsolete or in short supply.<sup>476</sup>

Throughout the U.S., stores of all kinds have posted signs by their cash registers, "due to a shortage of currency and coins", please use a credit card.





Crowds gathered outside of the Ohio Statehouse protesting coronavirus shutdowns.<sup>491</sup> New Hampshire's ban on gatherings of 50 people or more prompted a lawsuit.<sup>492</sup>

# 22. Legal Authorities for U.S. Public Health Officials & State Governors


"Generally, state and local public health agencies have broad and flexible authority to protect the public health. However, the exercise of governmental power has its limits.

The United States Constitution contains a Bill of Rights that sets out individual liberties and protects individuals from the arbitrary use of governmental power. These rights may

impact the extent of public health collection and sharing of information.


There is no "law" requiring anyone in the U.S. to wear a mask in public. Some public health officials and state governors may believe they have the authority to make such emergency decrees, but these decrees are not "law". Even with the state legislature's approval a governor cannot make laws and act outside or beyond the limits of U.S. Constitution.

### **Right to Privacy**

The Constitution provides a limited right to privacy, including "informational privacy." State laws that require reporting of or public health agency access to identifiable information are permissible when they are reasonably directed to the preservation of health and properly

respect a patient's confidentiality and privacy.

# Right Against Unreasonable Search & Seizure

Only with the owner's permission, may public health agencies enter or search the premises of an individual or business, take biological specimens or environmental samples for testing, copy records, and remove evidence that might be relevant to a public health concern.

However, absent consent or the applicability of another exception, public health agencies must comply with requirements in the U.S. Constitution's Fourth Amendment.

The Fourth Amendment of the U.S. Constitution, requires that a warrant be obtained, based upon probable cause, to search someone's premises or seize their property. The Fourth Amendment applies

to both criminal investigations as well as health and safety inspections, and investigations.

In addition to consent, other exceptions to the warrant and probable cause requirement may apply to public health inspections and investigations, including searches of pervasively regulated businesses, searches of premises or items open to the public, plus searches based on exigent circumstances if delay is likely to lead to injury, public harm, or the destruction of evidence.

### **Right Against Self-Incrimination**

The Fifth Amendment of the U.S. Constitution, right against self-incrimination, prevents the government from forcing an individual to be a witness against himself or herself during trial or a custodial interrogation.

If an individual is not informed of his or her right against self-incrimination, the individual's statements and evidence obtained as a result of these statements may be suppressed in criminal proceedings.

This right may arise when a public health incident involves criminal activity, especially when law enforcement and public health investigators are conducting joint interviews or public health agencies assist law enforcement to gather evidence."<sup>503</sup> There must be a balance between public safety and the preservation of civil rights.<sup>504</sup>

#### Title 42, §1983 Action

If a public health official or politician violates your civil and constitutional rights guaranteed by the U.S. Constitution and Bill of Rights, you can file a Title 42, §1983 claim against unwarranted, unauthorized public officials and hold the public servant personally liable.<sup>505</sup> See also: 42 U.S. Code §1983 – Civil action for deprivation of rights.<sup>506</sup> and 42 U.S. Code § 1983 – Civil action for deprivation of rights <a href="https://www.law.cornell.edu/uscode/text/42/1983/">https://www.law.cornell.edu/uscode/text/42/1983/</a>

Federal vaccine policy is coordinated by the National Vaccine Program Office (NVPO) of Health and Human Services (HHS), a government agency.<sup>507</sup>

The legislation that accelerated the implementation of a broad regime of vaccines for children and adults was the National Childhood Vaccine Injury Act of 1986 which indemnified vaccine manufacturers from vaccine injury claims.<sup>508</sup>

To protect the public from mandatory vaccination programs, this law must be repealed. Until Big Pharma takes responsibility for vaccine injuries and provides the appropriate health and safety studies, this public health disaster will continue.



Cherokee Indians, or European monarchs such as Queen Elizabeth.

# 23. Stimulus Bills Are Fast Tracks to Socialism & U.S. Bankruptcy

Throwing "free money" into the vast sea of the American people with

stimulus checks from the federal government is a slippery slope toward socialism, then comes communism. Due to the COVID-19 pandemic, every citizen has for the first time in American history received a \$1,200 stimulus check from the U.S. Treasury via the CARES Act (Coronavirus Aid, Relief and Economic Securities Act) of March 27, 2020.

Th CARES Act is a unique form of "welfare" we have never seen before. Indeed, this is the first step towards "nationalization", or socialism, whereby the government takes control over the production of goods and services.

Small businesses could either apply for a Payroll Protection Program (PPP) through their local bank to keep their employees on the payroll or apply for a low-interest small business loan through the Small Business Administration (SBA).

Pandemic Unemployment
Assistance was administered by each U.S. state. This is despite the fact that half of the U.S. states don't have enough funds to pay for their unemployment claims. 516

Corporate lobbyists have spent millions influencing the U.S. Congress to include their industries in the financial bailouts forthcoming from a series of stimulus bills which passed and were signed into law. The CARES Act was the

second most lobbied bill in history.<sup>517</sup> Furthermore, Trump signed the largest stimulus bill in modern history.<sup>518</sup>

Despite this stimulus money being dished out like candy, the fact remains that multiple, mistaken political responses by our leaders, will bankrupt far more people than COVID-19 kills.<sup>519</sup>

#### **Federal Reserve Bank**

Two days after the CARES Act was passed by the U.S. Congress and signed into law, U.S. President Trump took control of the Federal Reserve Bank (FRB) and placed under the authority and management of the U.S. Treasury via the CARES Act on March 29, 2020.<sup>520</sup>

This is the first time since the Federal Reserve Bank was founded in 1913 that the U.S. Treasury has been in control. Former U.S. Congressman Ron Paul (R-TX) advocated abolishing the Federal Reserve Bank for decades<sup>521</sup>, returning to the gold standard as the global reserve currency<sup>522</sup> and restoring a debt-free constitutional money system.<sup>523</sup> Trump effectively incorporated the FED



under the U.S. Treasury with the swipe of a pen.

The Federal Reserve Bank (FRB) is now looking into developing a digital currency, since oddly, cash seems to have become increasingly contaminated since COVID-19.<sup>524</sup> The CARES Act allows the Federal Reserve Bank to conduct meetings in secret and gives the FED a \$454 billion slush fund for Wall Street bailouts.<sup>525</sup>

The Federal Reserve Bank (FRB) cut interest prime rates to zero and launched



a massive \$700 billion quantitative easing program (i.e., printing money out of thin air). The Federal Reserve Bank and U.S. Treasury have pumped a staggering \$6 trillion into the economy since March 2020. 527

Within two days after receiving a massive amount of stimulus money from the CARES Act, two of the largest investments banks in the U.S., Goldman and Morgan Stanley, immediately invested in majority stakes in Chinese ventures, thereby becoming 51% owners of an investments bank in China. Interesting to discover where their loyalties are. <sup>528</sup> At the same time, U.S. President Trump moved to block U.S. pension fund investments in Chinese equities. <sup>529</sup>

The Federal Reserve Bank was considering implementing a "negative interest rate" of 0.25%. A negative interest rate means that borrowers get paid to take out loans by lenders. This has been adopted by a number of Central Banking Systems around the world, led by some European Central Banks as well as the Bank of Japan, with mixed results.

If a Central Bank sets its overnight deposit rate to below zero, lenders must pay their central bank to hold their reserves. Banks could then pass those costs on to their customers, charging fees for positive balances.

Some economists believe negative interest rates can jolt life into flatlining economies, encouraging money to be invested or spent, though other economists argue that a negative interest rate policy could keep an economy subdued.<sup>530</sup>

#### Weirdness on Wall Street

There is very strange economic weirdness happening on Wall Street and a huge reset of equity.<sup>531</sup> Ever since the market crash at the inception of the pandemic, the ultra-rich have become strikingly more ultra-rich than ever.

By letting small businesses fail, many of the states are handing even more concentrated power over to the large corporations while transferring even more wealth to the transnational giants who already dominate the global economy.<sup>532</sup>

Various state shutdowns have already taken a quarter of U.S. economy offline in 2020 and even more in the European Union and other countries around the world.<sup>533</sup> The hasty overreaction to COVID-19 had cost the global economy at least \$2.7 trillion by March 2020, and much, much more for the rest of 2020.<sup>534</sup> For more information, see "Bloomberg Recovery Tracker".<sup>535</sup>


outbreak first emerged in the central Chinese city of Wuhan in late 2019.555

Wuhan may be over 40,000, more than 16 times the amount reported. <sup>570</sup> Wuhan conducted citywide testing after new coronavirus cases emerged. <sup>571</sup> Beijing's claim of no new infections contradicts the reality on the ground. <sup>572</sup>

It is now estimated that 460,000 Chinese businesses went under in first quarter of 2020 due to COVID-19. This fact has not been reported in China's positive-only "China News".

The Chinese ambassador to the U.S., said that America must make a "fundamental choice" about whether it can live peacefully with a "modernized, strong, prosperous" China. Under President Xi Jinping, China has become more assertive, expansionist and a more repressive power. "

"I think that the fundamental question for the United States is very simple," he said.



"Is the United States ready or willing to live with another country with a very different culture, a very different political and economic system...in peace and cooperate on so many and still growing global challenges?"578

### **5G Competition for World Domination**

5G network technology developed by the Chinese is being exported around the world. It includes security risks that have only recently come to the attention of Western governments.


Thus, the U.S. has banned Huawei and ZTE from providing 5G service in the U.S. as it has an internet backend controlled by the Chinese Communist Party (CCP) which can be used to spy on or control the connected technology without the knowledge or consent of the

user. Australia has also banned the same Chinese technology companies from providing internet service. <sup>579</sup> Canada's military would like Trudeau to do the same. <sup>580</sup>

How did the U.S. become so economically dependent on China?<sup>581</sup> U.S. President Trump has been economically decoupling the U.S. from China and relocating critical China-centric supply chains back to the U.S.<sup>582</sup> While the U.S. manufacturing exodus from China gets underway, the move is primarily to

Vietnam, Burma, Philippines and Bangladesh.<sup>583</sup>

The State of Missouri is suing China, including the Wuhan Institute of Virology, for damages and harm due to the COVID-19 outbreak.<sup>584</sup>

As a possible act of war, China has conceivably killed half a million people around the world from COVID-19 due to the CCP's negligence and failure to inform the world of an impending pandemic.<sup>585</sup>

U.S. Senator Marsha Blackburn (R-TN) suggested China should forgive U.S. debt as restitution for releasing COVID-19 and causing so much economic damage to the U.S. economy.<sup>586</sup>

U.S. Congressman Lance Gooden (R-TX) has introduced a bill opening the pathway for lawsuits against the Chinese regime for damages during the COVID-19 pandemic.<sup>587</sup>

A Conservative U.K. Think Tank, The Henry Jackson Society, argued that China should be sued for trillions in damages because of the COVID-19 pandemic.<sup>588</sup>
